2019 Annual Report of BCNL

The year 2019 was different. The usual problems facing the sector – lack of funding, a variety of topics and concerns, arguments with the institutions – did not seem to be topical. The reality is that we were confronted with by far more serious issues and challenges, as we like to refer to them in the NGO slang. The questions asked (including by serious media and journalists) in the public space were: Are NGOs helpful to the society and in what ways; Don't they just act as channels for foreign interests; Are they indeed "non-governmental", etc. The propaganda reached an important point – an attack against NGOs as such (not against NGOs for reasons of their specific activity – green, child-oriented, gender-oriented, etc. – as it had been over recent years, but against NGOs as a public construction).

The question should not be WHY? It is obvious! Civil society organizations are the guardian of last resort for the democratic values in a state where the other actors have increasingly refused to ensure them – the court, the institutions, the media, etc. If we are real actors in defending the national interests of a state with democracy and the rule of law; if we fight to be the platform where the rights and freedoms of each individual are protected, where human dignity is a high value and the guiding principle is the rule of law; if this is our version of development – it would be a pity if we were not a target of attacks. BECAUSE we are the guarantors who will always believe in these values, and will seek ways to ensure that they are further rooted in our public culture and behavior. Are we prepared to show that we act as a

guarantor? Needless to ask this question. We are ready.

As long as confrontation is imposed on us, we will aim at a constructive discussion and dialogue; as long as we are vilified, our thoughts will be about those who are really vulnerable and our minds will be devoted to helping them; as long as the divide is being deepened, we will build up communities.

This will be our line of action, as we know that in a democratic society the lack of freedom for one individual implies the lack of freedom for all its members; that dialogue is the way for us to go forward; that there is space for everyone. And first and foremost, we know that those working in the Bulgarian civil society sector are individuals who volunteer and support some of the most talented people in Bulgaria, and who believe that our country is a nice place, with a lot of potential and goodness which are worth developing.

It is with this confidence that we are starting the year 2020 and the new decade.

In October we started the Vihrogontsi (vortex) sequence at the House of NGOs: a series of motivational presentations by fans of movement - travelers, nature lovers, adventurers, athletes – in which they tell their stories and inspire others to be active and search for a cause in everything they do.

The sequence started with 4 vortex story tellers who guided 60 guests, on foot or on bikes, to the mountain ranges in the USA, the cycling routes in Eastern Africa, the exotic customs in Southeastern Asia, and the challenge – 1,000 km of charity.

What Have We Changed In The Legal Framework

In 2019 we continued **providing support to CSOs by means of consultations** on preparing their documents for registration and re-registration with the Registry Agency, as well as on general compliance in order to maintain a perfect status.

An important development in 2019 was the entry into force of the Regulation for the application of the new Measures against Money Laundering Act. As a result of an initiative by BCNL, amendments were made to the law which significantly alleviated the task for many non-profit legal entities to enter data about the real owner (there is no need to additionally enter data about the real owner registered beforehand on different grounds). In relation to this topic, the State Agency for National Security issued special instructions making this obligation of non-profit legal entities clearer and preventing controversial application of the law.

Following a 5-year debate, the Social Services Act was passed by the National Assembly in early 2019. Regrettably, the Ministry of Labor and Social Policy missed the opportunity to conduct an appropriate awareness-raising campaign. Thus, the autumn of 2019 witnessed growing attacks on the law that had already been passed and, as a whole, on the role of NGOs in the process of social consultations. An informal coalition of NGOs involved in the social area responded by publishing open letters on the topic. Regrettably, due to the absence of an impact assessment and large-scale public consultations, in the last days of 2019 the National Assembly postponed the entry into force of the law till July 2020, which resulted in a failure to use the opportunity for launching the social reform.



At the end of November in 2019 the Bulgarian legal community organized a meeting in Sofia to mark the 30th anniversary of the adoption of the Convention on the Rights of the Child. This anniversary was an occasion to review and assess the extent to which the Convention is properly understood in Bulgaria, accepted and implemented in the spirit of its legal provisions, as intended by the State Parties to the Convention. The event was attended by 120 representatives of various legal professions from Bulgaria and from abroad magistrates, lawyers, academia, human rights activists - and civil society representatives. The organizers of this large-scale forum were the Bulgarian Center for Non-Profit Law (BCNL), the National Institute of Justice, the Supreme Bar Council, the Institute for the State and the Law with the Bulgarian Academy of Science. The event was organized with the support of UNICEF.

An important change in the legislation concerning people with disabilities was the entry into force of the Persons with Disabilities Act, the supported decision-making (SDM) concept being introduced in the section "Access to Justice". This was a significant step forward in ensuring equality before the law for all people with

disabilities, including individuals with intellectual difficulties and mental health problems. BCNL, GIP (Global Initiative on Psychiatry) and BAPID (Bulgarian Association for Persons with Intellectual Disabilities) continued working hard with the aim to change the practice whereby persons with mental disabilities participate in court proceedings. In addition to the exchange of experience and ideas with other states, we also applied some new approaches to court cases concerning forced medical treatment of persons under full guardianship with the aim ensure their access to a fair trial.

We were very happy with the internship of Samantha Beckmann– a student from McGill University, Canada – who produced an extremely interesting comparative report on jurisdictions across the world where guardianship has been revoked and replaced with SDM. In 2019 we started a 3-year joint project with the Global Initiative on Psychiatry-Sofia and the Union of Judges "Exiure ad iustatium (From justice to fairness); principles of a fair trial for persons with disabilities" – the objective of the project is uniting the efforts of judges, lawyers, civil society organizations in developing and implementing an innovative algorithm for applying procedures which safeguard the rule of law in conformity with the latest international human rights acts.

We are happy to point out that we will intensify our activity related to a very important topic for NGOs – improving the access to employment for people with disabilities. We started a new joint project with Maria's World Foundation "I can work! Employment support for people with intellectual difficulties" with a focus on implementing an efficient model to support access to employment for persons with special needs.

"Entrepreneurship for Non-Profit Organizations" is an important program for us. The successes of the participating organizations prove that NGOs who have mission-related entrepreneurship activities:

- **Generate confidence** civil society organizations are organizations of the people;
- Bring the community together this is a model with the involvement of everybody;
- Provide sustainable support to people in a way tailored to the needs, as entrepreneurship can adapt to people's needs.

12 organizations which were involved in the initial training period participated in the 8th edition of Entrepreneurship for Non-Profit Organizations; 11 of them took part in the competition "The Best NGO Business Plan", and the five best ideas ensured financing in the amount of 8,000 BGN for the relevant organizations.

The finalists received mentorship support during the first 6 months for implementing their ideas – they had meetings with the 22 experts from businesses and social entrepreneurs who offered them individual counseling and guidance for a successful start-up.



The annual Bazar of Social Enterprises, which is part of the Program, started a life of its own, with a new name: **Bazar** "A Little means a Lot" and 4 new editions – in addition to the traditional edition in Serdika Center in February, the Bazar had an edition in the town of Montana during the Festival of Social Entrepreneurship, and another one for Easter at the National Assembly where decision-makers received a very clear message that any cause aiming at fairer solutions for the others is worthwhile; as well as 2 Christmas editions hosted by Accenture Bulgaria and Telus International Bulgaria – partners of the Program. The 2019 Bazar "A Little means a Lot" had over 5.000 visitors.



A crucial development for the Program and its progress is a project we started in December 2019 – a project uniting organizations and businesses which became part of the supporting environment for social enterprises. This is www.DarPazar.bg – a place where you will find products and services with a cause offered by civil society organizations and other social enterprises in Bulgaria.

- 24 social enterprises have been registered in DarPazar
- Over 250 products and services with a cause have been uploaded on the platform

Civil Alarm Clock is our program encouraging young creators who use the power of socially engaged art to tell us about their rights and show them through their works. The special focus in 2019 were the children workshops within the framework of the 2019 Civil Week of Culture which we organized together with ALOS Center. The three workshops involved 50 school children from the 3rd to the 5th grade (aged between 9 and 11) who illustrated their understanding of rights through their creation. An exhibition with the children's paintings and collages was organized at School No 120 "G. S. Rakovski".

In the spring and autumn of 2019 the House was once again revived, with people seeking knowledge and skills in the civil sector. The topics in the Training program of the House – personal data protection, campaigns in the social media, financial management, marketing for NGOs, etc. attracted not only people from civil society organizations but also active citizens seeking new development opportunities.

The sequence "Vihrogontzi" fueled the House with new energy from people seeking adventure, united by the common cause of acting as ambassadors of good by means of their deeds.

Making Organizations Active

In 2019 we put efforts into launching several new initiatives with the aim to generate **new civic energy and support for the organizations**:

Bulgaria donates – a coalition of 12 organizations united by the idea to encourage donorship and support for civic causes – had its first edition in March 2019. BCNL was the coordinator of the first edition within which:

- Over 120 causes were registered on the platform
- Over 50,000 BGN were donated within one week

Another promising initiative is aimed to **support volunteering**. 10 organizations signed a memorandum whereby they committed to conducting a national campaign in support of volunteering in 2020.

Our partnership with Sofia Municipality was important within the framework of the coalition of over 30 organizations with which we organized a **forum for the quality of social services**. The voice of consumers and their families played the leading role in the forum.

In late 2019 we started a new project aimed at creating civic hubs at Sofia University and Plovdiv University which will serve to galvanize the energy of students and organizations to the benefit of the society.

Together with the Program and Analytical Center for European Law, we launched a new initiative "For the citizens and their organizations" which will contribute to improving the legal culture of NGOs and will raise awareness about NGOs and their activity.

Jointly with the Citizen Participation Forum, we will improve **the Portal for citizens in 2020** – public consultations and the tools used by the community in decision-making at the local level.



INDEPENDENT AUDITOR'S REPORT

To the management of Bulgarian Center for Not-for-Profit Law Sofia

Opinio

We have audited the financial statements of Bulgarian Center for Not-for-Profit Law (the Foundation), which comprise the balance sheet as at 31 December 2019, and the income statement, equity statement and cash flow statement for the year then ended, and note to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion, the accompanying financial statements present fairly, in all material respects the financial position of the Foundation as at 31 December 2019, and its financial performance and its cash flows for the year then ended in accordance with National Accounting Standards (NAS) applicable in Bulgaria.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Foundation in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) together with the ethical requirements of the Independent Financial Audit Act (IFAA) that are relevant to our audit of the financial statements in Bulgaria, and we have fulfilled our other ethical responsibilities in accordance with

the requirements of the IFAA and the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with NAS applicable in Bulgaria and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Foundation's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Foundation or to cease operations, or has no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit
 procedures that are appropriate in the circumstances, but not for the purpose of expressing an
 opinion on the effectiveness of the Foundation's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Foundation's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are

NOTES TO THE FINANCIAL STATEMENTS for the year ending on December 31, 2019

1. Incorporation and registration.

The Foundation Bulgarian Center for Not-for-Profit Law (BCNL) was established in 2001 and is registered in accordance with the Law for the non-profit corporate bodies. The foundation works for the public benefit and is registered in the Ministry of Justice.

The Foundation is a non-governmental, non-political and non-religious organisation, established to pursue the following objectives:

- to support the development and strengthening of an enabling legal and policy environment for an independent civil society, incl. non—governmental, not-for-profit organizations (NGOs), in Bulgaria;
- to promote transparency, accountability, and proper internal governance of NGOs and state institutions:
- to support better cooperation between government and NGOs;
- · to support public participation in decision-making;
- to promote the development of professional skills, knowledge and capacity relating to the enabling legal environment for civil society, including NGOs, in Bulgaria;
- · to provide assistance to NGOs with respect to legal problems;
- to provide assistance in civil society legal reform efforts in other countries, where appropriate, and to foster international co-operation;
- to engage in activities to achieve such other objectives as determined by the Board of Trustees not
 inconsistent with the purposes and the identity of the Foundation

2. Description of the significant accounting policies

2.1. Basis for the preparation of the financial statements

The Foundation annual financial statements for the year 2019 have been prepared in accordance with the requirements of all the National Accounting Standards applicable in 2019, as of the Balance sheet date of December 31, 2019.

The Foundation organizes and carries out the current accounting reports and prepares its financial statements in accordance with the requirements of the Bulgarian accounting, taxation and commercial legislation.

The Foundation financial statements for the year 2019 are prepared according to the requirements of the principles of accrual basis; going concern: primacy of content over form; prudence; comparability of income and expense; consistency.

These financial statements have been prepared on the basis of the accounting convention of historical price, modified in certain cases with the revaluation of some assets and liabilities in accordance with their fair value, that have been shown in the disclosures accompanying the statements.

All information disclosed for 2019 and 2018 is presented in this financial statement in thousands of Bulgarian leva (BGN in thousands).

2.2. Comparative data - changes in accounting policies

With a view to achieving comparability, the balances in the respective accounts of Retained Earnings and Reserves as of December 31, 2019, have been reclassified, combined and recalculated. All adjustments have been reflected in Reserves and Retained Earnings so that they would not influence the current financial result.

2.3. Use of accounting estimates and assumptions

The preparation of financial statements under the National Accounting Standards requires that the management makes some accounting estimates and assumptions, which are related to the Balance sheet reported assets and liabilities as well as to the recognized income and expenses for the period.

2.4. Transactions in foreign currencies

Transactions, concluded in foreign currencies during the period, have been translated in Bulgarian leva in accordance with the exchange rate for the respective currency on the date of the transaction. Any assets and liabilities in foreign currencies have been recalculated in accordance with the closing exchange rate of the Bulgarian National Bank as of the Balance sheet date. Any profit or loss as a result of this has been presented in the Income Statement.

2.5. Recognition of income and expense

The sources of this income are the grants received. Solely the disbursed parts of these grants are accounted as income during the year. The disbursed as income grants, for which there are attended clauses, are specified as financing under conditions in the Profit and Loss Account. The income from the grants for fixed assets is recognized only to the extent of the allowances for depreciation and the balance is reflected in the Balance sheet as long-term liabilities /deferred income and financing/. Unrealized financial resources during the year are specified in the Balance sheet as short-term or long term financing, depending on the period for which they will be disbursed. The realized expenses, exceeding the grants received to the date of the financial statement, are recognized as income and reported as other short-term receivables in the Balance sheet.

Expenses are recognized in accordance with the principles of accrual basis and comparability with Income. Most of the depreciation expenses are directly assigned to reduction of equity of the Foundation and are not recorded in the Income Statement.

of accrual basis and comparability.

2.6. Fixed assets

Fixed assets are the established non-financial resources, which have been acquired and are owned by the Foundation, and have a physical existence. It is expected that they will be used during more than one reporting period. The fixed tangible and intangible assets have been valuated at acquisition cost which includes their purchase price plus all expenses in relation to their commissioning and are reduced with the accrued depreciation and impairment.

Any derecognition of fixed assets is made as a result of a sale, reject or retirement when no other economic benefit is expected.

2.7. Depreciation of fixed assets and amortization of intangible assets

The Foundation accrues depreciation of fixed assets and intangible assets in view of the useful life of the individual assets, determined for each class of assets. No depreciation is accrued for lands and assets that are under construction or being sunpilied.

When depreciable assets of the company are depreciated, the straight-line method is used.

In 2019 the following depreciation rates have been used:

Computers - 50%

Office furniture - 15%

2.8. Receivables

The receivables have been valuated at their incidence cost.

2.9. Cash

Any cash in BGN has been valuated at face value, while cash in foreign currencies - in accordance with the closing exchange rate of the Bulgarian National Bank on December 31, 2019. For the purposes of the Cash Flow Statement, the cash includes all cash in hand and at bank as of December 31, 2019.

2.10. Current liabilities

Any current liabilities in BGN are valuated at their incidence cost.

2.11. Income taxes

Under the Bulgarian tax legislation, the Foundation is liable to corporate taxation only for its economic activity. The tax percentage is 10 % of the taxable profit. In the period only the payment for technical services rendered by foreigners is liable to withholding taxation. The Foundation did not make any social expenses during the period.
